Sweep the split toner or remove it with a vacuum cleaner, and transfer into sealed container carefully. Sweep slowly to minimize generation of dust during clean-up. If the vacuum cleaner is used, the motor must be rated as dust explosion-proof. A conductive horse bonded to the machine should be used to reduce static build-up.
